- ii) There is possible to create orthographical dictionary or IC in the mobile phone. This can be one more facility provided by the various mobile companies.
- iii) Orthographical style can be adopted as the pedagogical implications.
- iv) This is further scope for the researcher those who are willing to do research in language or linguistics.

13. Summary of the Findings:

It is well known that cell-phone is 3G (i.e. Third Generation) in respect of technology. Sending sms-text via cell-phone is one of the best ways of the informal written communication. Now, majority of the language of the world have come in contact with each other. Through this contact one code (one language) is used into another. It means consciously or unconsciously the cell-phone users have applied linguistic aspects of borrowing in the sms-text without following linguistics' frame. It is beyond the traditional rules of linguistics. It does not mean that the sms-text violates the rules. These sms-texts are known as the sample orthographical style in English language. It is emerging as a new branch of linguistics and is based on the origin of the Standard English Language. All these formations are followed in these sms-

texts. Moreover, it has social acceptance and is being used by the common people of the present society of the world.

Reasons of Orthographical Style Used in SMS

Many linguistic features are found regarding the sms-texts. Those are used by the cell-phone users. When the cell-phone users access the sms-texts at the time they have such psychology. It means their mentality, their attitude, their way of thinking, their interaction with each other and so on. Along with these reasons there are more reasons sought out through interactions with the cell-phone users and other exercises. In other words, the sms-texts are considered as a literary piece. These sms-texts have studied from linguistics point of view, mainly, the reasons behind using such style in English. These are as:

1. Novelty and Appeal of the Orthographical Style Used in SMS

The sms-text attracts attention of the reader because the texts make use of novel signs and make imaginative use of language. There is no problem to understand its message. It is true that these messages use abbreviation, clip the words, use unfamiliar combinations, use emoticons, etc. Yes, they are quite effective in communicating the message. The readers enjoy deciphering the messages, and are encouraged to use innovative means of expression. They attract attention of the reader.

2. It Saves Time and Money

The persons who are far away from one another can easily interact with each other through the cell-phone. It may be a part of their business. It saves them time and money. This is an era of quick communication in the present globalize world. Everyone is busy in their work. They do not want waste their

time and money. So, for the sake of saving time and money they use technological support of electronic media i.e. cell-phone, internet, etc. They access it for sending or writing sms-texts to each other. Written sms-text or message is one of the cheapest facilities available in the cell-phone. It is quick and economical. Moreover, the cell-phone users are now accustomed to the brevity of this system of communication.

3. Limitations of Cell-phone Communication

- i) Cell-phone, an electronic instrument, is used by the commonest persons of the society. For the purpose of business a person can come in contact with another one. If the person's mother tongue is different from another one, then there may be non-standard use of language. There is an interaction going on between two different speakers of language, using English in the sms-texts. The cell-phone users may take liberty with the structure and vocabulary of English or they may mix codes, sometimes hampering communication. Innovations by the sender of the messages may not be readily understood.
- ii) Communication may be hampered by clipping the spelling of the words or using some unfamiliar sign or symbol. It is necessary to use enough contextual signals to make communication possible.
- iii) Use of fragmentary structures: Cell-phone communication abounds in fragmentary structures. The cell-phone users make use of only phrases, single words, clipped colloquial expressions, etc. Their use of language is utility oriented and pragmatic.
- iv) Use of Innovations: Innovations are used in the commercial world while naming a product and advertising it. As we have been already, spellings of the

words, their printing convention, use of capital letters, etc. are used by the advertisers to attract attention of the customers.

The mobile messages or sms-text are produced by using orthographical style in English. The orthographical style is based on the Standard English Language originally. It helps to the society that how to use correctly in the written contexts.
