MEMORANDUM OF UNDERSTANDING

Purpose:

This Memorandum of Understanding (MOU) establishes a collaborative relationship between Rayat Shikshan Sanstha, Annasaheb Awate Arts, Commerce & Hutatma Babu Genu Science College, Manchar, Tal. Ambegaon, Dist. Pune 410503 and Vigyan Ashram, Pabal, Pune to organise an educational program for the Electronic Science Department. The program aims to conduct study camps and project guidance for final-year students.

Article 1: Objectives

1. To provide internship for students.
2. To conduct a study camp that focuses on practical applications of fundamental science principles and skills.
3. To provide project guidance for final year students working on their capstone projects in Electronic Science.
4. To arrange field visits at Vigyan ashram to explore new technologies.

Article 2: Responsibilities of College

1. Provide a list of participating students and faculty members.
2. Coordinate with Vigyan Ashram to finalize the study camp schedule and project themes/topics.
3. Ensure students are prepared for participation in the study camp, including any necessary materials or prerequisites.

Article 3: Responsibilities of Vigyan Ashram

1. Provide facilities and resources necessary for conducting the study camp.
2. Offer mentorship and guidance for the students during the camp and project assistance.
3. Organize workshops, lectures, and hands-on projects related to Electronic Science.

Article 4: Timeline

1. The study camp will commence on January 2nd Week and February second week.
2. Specific dates for project guidance for last year's students' sessions will be agreed upon at least 6 weeks for both semesters.

Sem -I: August to September

Sem-II: December to January

Article 5: Funding

- Any costs incurred related to the study camp and project guidance will be addressed by student will cover costs, or detail a funding arrangement, if applicable.

Article 6: Confidentiality

- Both parties agree to maintain the confidentiality of any proprietary information exchanged during the collaboration.

Article 7: Tenure and Terms of Amendment

- This MOU, unless extended by mutual written agreement of the parties, shall be effective for up to three (3) years from the date of the agreement specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written

agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon thirty (30) days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any Research Agreement (for their respective duration/tenure), Confidentiality clause above. Referenced in clause 6 or any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination, for a period of three (3) years thereafter.

- This MOU may be amended at any time by mutual consent of both parties, provided that such amendments are documented in writing.

Article 8: Termination

Either Party may at any time terminate this MoU by giving the other Party not less than thirty [30] days prior written notice. Further, either Party shall be entitled to forthwith terminate this MoU, if (a) Representatives of other Party breaches any term hereof, (b) Representatives of other Party breaches any law, order, regulation or direction of any statutory, judicial or quasi-judicial authority, or (c) any allegation of moral turpitude, ineptitude, misconduct or negligence is made against Representatives of other Party.

Article 9: Signatures

This MOU reflects the understanding and agreement between Annasaheb Awate Arts, Commerce & Hutatma Babu Genu Science College, Manchar and Vigyan Ashram, Pabal.
